Waiver of Claim for Damages and
Consent to Locate Road

We, the undersigned, being the owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way one hundred twenty (120) feet in width over and across the following described piece or parcel of land, to-wit:

The Southwest quarter of Section 2;

The Southwest quarter of the Northwest quarter of Section 2, EXCEPT that portion thereof conveyed to Mansuetto Tavelli by deed dated January 14, 1908, described as follows: Beginning at a point in the center of the County Road 7.56 chains North of the quarter corner on the West line of the said Section 2; thence North 18° 25' East 6 chains; thence North 58° 33' East 4.71 chains; thence North 58° 16' East 2.02 chains; thence North 56° 15' East 2 chains; thence North 61° 18' East 1.87 chains; thence South 87° 03' East 9 chains; thence North 1.77 chains; thence West 20 chains to the Northwest corner of the Southwest quarter of the said Section 2; thence South 12.87 chains to the point of beginning.

Said right of way granted for construction and maintenance of a cul-de-sac at the northerly end of the County Road known and designated Miller Road (County Road No. 1127) as existing in March 1972.

More particularly described as follows:

A circular piece of land with a radius of sixty (60) feet, said radius to begin 60 feet north of the south line of Section 2, Township 1 North, Range 5 E.W.M. and 986 feet east of the southwest corner of Section 2, Township 1 North, Range 5 E. W.M.

and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a County Road.

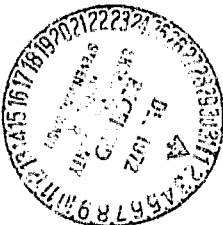
