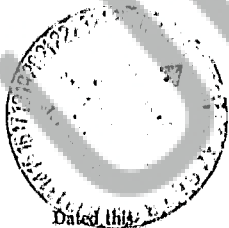
In hand paid, conveys and warrants to GILBERT O. STOLLER and MERIDETH M. STOLLER,
