On the following terms and conditions: The purchase price is Three Thousand Nine Hundred Ninety-Two Hundred Eighteen and 71/100ths - has been paid, the receipt when the r Five and no/100ths -(\$ 3,995.00) dollars, of which (\$ 218.71) dollars has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said purchase price as follows:

The purchaser agrees to pay the balance of the purchase price in the sum of Three Thousand Seven Hundred Seventy-six and 29/100ths (\$3,776.29) Dollars in monthly installments of Fifty and no/100ths (\$50.00) Dollars, or more, commencing on the 20th day of January, 1973, and on the 20th day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The property has been carefully inspected by the purchaser, and no agreements or representations per-taining thereto, or to this transaction, have been made, save such as are stated herein.

The purchaser agrees: to pay before delinquency all taxes and assessments assumed by him, if any, and any which may, as between grantor and grantee, hereafter become a lien on the premises; not to permit waste; and not to use the premises for any illigal purpose. If the purchaser shall fail to pay before delinquency any such taxes or assessments, the seller may pay them, and the amounts so paid shall be deemed part of the purchase price and be payable forthwith with interest at the rate of ten per cent per annum until paid, without prejudice to any other right of the seller by reason of such failure.
