## COMMUNITY PROPERTY AGREEMENT

This COMMUNITY PROPERTY AGREEMENT entered into this day by and between MICHAEL ALMASI and WALBORG J. ALMASI, husband and wife, of North Bonnaville, Skemenia County, State of Washington:

## WITNESSETHE

WHEREAS, the parties hereto are the owners of certain real and parsonal property in the State of Washington; and

ALMASI, husband and wife, for and in consideration of the love and affection which we have one for the other, do hereby mutually agree that all of the property which we now own separately, jointly or otherwise, and whether real, personal or otherwise, and situated in the State of Washington, shall be and it is hereby declared to be the community property of the parties, and each of the parties to this agreement does hereby corry and transfer to the other party and to the community, all property ewned by them in the State of Washington, even though the same be held in his or her separate estate; and

We hereby mutually agree that all of the property which shall hereafter be acquired by hither of us, whather separatoly, jointly or otherwise, and of whitsomever mature and situated to the State of Washington, shall be and it is hereby declared to be community property, and each of the parties does hereby convey and transfer to the other and to the community all such property hereafter acquired by either of them, even though the same be acquired in his or her separate estate; and
