

QUITCLAIM DEED

The Grantor, ELIZABETH MAHIEU, formerly Elizabeth Balsiger, remarried widow of George E. Balsiger, deceased, as her separate estate, for and in consideration of ONE DOLLAR (\$1.00), in hand paid by Merlin Fink and Donna Fink, does hereby convey and quitclaim unto the said Merlin Fink and Donna Fink, all her right, title, and interest in and to the following-described real property situated in the County of Skamania, in the State of Washington, to wit:

Beginning at a point on easterly right-of-way of County Road known as Laycock Road, at its intersection with North boundary line of NW $\frac{1}{4}$ of Section 15, Township 3 North, Range 10 East, Willamette Meridian, said point being 550 feet east of Northwest corner of Section 15, above Township and Range; thence Southerly along Easterly right-of-way line of said County Road to South boundary line of NW $\frac{1}{4}$ of Section 15, said Township and Range, thence East along south boundary line of NW $\frac{1}{4}$ of Section 15, said Township and Range, 1692 feet more or less, thence North 808 feet along west boundary line of a 15 acre tract situated in Southeast corner of said NW $\frac{1}{4}$; thence East 808 feet to East boundary line of said Northwest quarter; thence North along East boundary line of said NW $\frac{1}{4}$ to Northeast corner of said NW $\frac{1}{4}$ of Section 15; thence West along North boundary line of said NW $\frac{1}{4}$, 2111 feet to point of beginning (excepting a 10 acre tract located on NE $\frac{1}{4}$ of said NW $\frac{1}{4}$).

The above described parcel contains 93 acres, more or less.

This deed is given for the purpose of enabling the Transamerica Title Insurance Company to omit any reference to the said Elizabeth Balsiger's interest in said real property in its policy of title insurance No. S-5796.

TO HAVE AND TO HOLD said premises unto the said Merlin Fink and Donna Fink, forever.

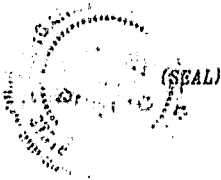
