 in hand paid, conveys and warrants to Allen G. Short and Betty L. Short, husband and wife
 the following described real estate, situated in the County of Skamania, State of Washington:

Beginning at a point in the center of 40 foot county road known as Burns Road which is 1718.70 feet North and 1122.65 feet West of the Section corner of 20, 21, 28 & 29, Township 2 North, Range 5 East of the Willamette Meridian; thence South 29° 36' West 25.10 feet along the center of said road to Co. Eng. station 48; thence South 44° 20' West 124.35 feet to the true point of beginning. Continuing along said road for 124 feet; thence North 89° 30' West 350 feet more or less to the center of the North Fork of the Washougal River; thence upstream North 8° East 101 feet; thence continuing in a Easterly direction to the true point of beginning, containing one acre more or less all in the North half of the Southeast quarter of Section 20, Township 2 North, Range 5 East of the Willamette Meridian, except County road.
