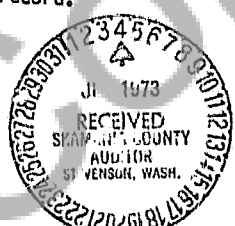
THE GRANTOR S, JOHN B. ZEVELY and LORRAINE M. ZEVELY, husband and wife,
