

QUIT CLAIM DEED

THE GRANTORS, GAY M. MARGADO and PATRICIA J. MARGADO, husband and wife, residing in Stevenson, Washington, for and in consideration of the sum of Eight Thousand and no/100 Dollars (\$8,000.00), conveys and quit claims to WALTER KATRYNYNIUK and GUS BERKONZINE, all their interest in and to the following described real estate situated in Skamania County, Washington:

TRACT A: That portion of the NW_{1/4} of the SW_{1/4} of Section 36, township 3 North, Range 7 E.W.M., more particularly described as:

Beginning at the NW corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 36; thence S along the W line thereof to a point 20 ft.
