THE GRANTOR, ROY D. ZIEGLER, individually and as executor of the estate of CHARLES ZIEGLER, deceased, for and in consideration of Fourteen Thousand One Hundred and No/100ths Dollars (\$14,100.00), in hand paid, conveys and warrants to <sup>KIPLING P.</sup> ~~XXXX~~ ASLIN and HELEN/ASLIN, husband and wife, the following real estate situate in Skamania County, Washington, with appurtenances thereon:

A tract of land located in Section 36, Township 3 North, Range 7 E.W.M., described as follows:

Beginning at the northeast corner of a tract of land conveyed to Richard W. O'Neal, et ux., by deed dated April 19, 1950, and recorded at page 68 of Book 33 of Deeds, Records of Skamania County, Washington; thence south 15° 10' east to intersection with the center line of County Road known and designated as Gropper Road, said point being the initial point of the tract hereby described; thence north 15° 10' west 125 feet; thence east 84 feet; thence south 15° 10' east 125 feet, more or less, to the center line of Gropper Road; thence westerly following the center line of said road to the initial point.

CHARLES ZIEGLER died on the 21st day of February, 1973, and ROY D. 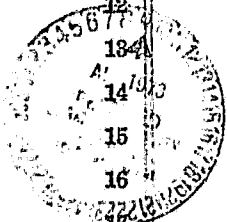

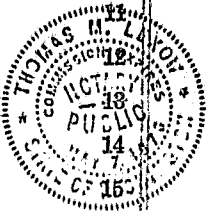
