REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this 30th August, 1971,

and conditions of this contract are as follows: The purchase price is Saventeen Thousand One Hundred Seventy and no/100ths -(\$ 17,170.00) Dollars, of which One Thousand Six Hundred Seventy and no/100ths -(\$ 1,670.00) Dollars have been paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows:

The purchasers agree to pay the balance of the purchase price in the sum of Fifteen Thousand Five Hundred and no/100ths (\$15,500.00) Dollars in monthly installments of One Hundred Mirty and no/100ths (\$130.00) Dollars, or more, commencing on the 5th day of November, 1971, and on the 5th day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest at the rate of eight per-sent (8%) per annum from August 30, 1971, computed upon the munthly balances of the unpaid purchase price, and said monthly installments shall also include real property taxes pre-paid by the seller and pro-rated monthly. Said monthly installments shall be applied first to pro-rated advances of the seller for taxes, then to interest, and finally to principal. The purchasers reserve the right at any time they are not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus interest then due.

(1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may as between grantor and grantechereafter become a lien on said real estate; and if by the terms of this contract the purchaser has assumed payment of any mortgage, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lien on said real estate, the purchaser agrees to pay the zame before delinquency.

In case any part of said real estate is taken; for public use, the portion of the condemnation award remaining after payment of reasonable expenses of procuring the same shall be paid to the seller and applied as payment on the purchase price herein unless the seller elects to allow the purchaser to apply all or a portion of such condemnation award to the rebuilding or restoration of improvements damaged by such taking. In case of damage or destruction from a peril insured against, the proceeds of such famprovements within a reasonable time, unless purchaser elects that said proceeds shall be paid to the seller for application on the purchase trice herein. purchase price herein.

(5) The seller has delivared, or agrees to deliver within 13 days of the date of closing, a purchaser's policy of title insurant in standard form, or a commitment therefor, issued by Frensemerica Fills insurance Company, insuring the purchaser to the full amount of said purchase prior against loss or daying by reason of defect in seller's title to said real estate as of the date of closing and containing no exceptions other than the following:

a. Printed general exceptions appearing in said policy form;

b. Liens of encumbrances which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be made subject; and
