## COMMUNITY PROPERTY AGREEMENT

This COMMUNITY PROPERTY AGREEMENT entered into this day by and between FREE E. NYSTROM and L. YVONKE MYSTROM, husband and wife, of Stevenson in Skemania County, State of Washington;

## WITHESSETH

WHEREAS, the parties hereto are the owners of certain real and porsonal property

WHEREAS, it is contemplated by the parties hereto that in the future they may acquire additional property situated in the State of Washington; and

WHEREAS, it is the desire of the parties hereto that all of their property situated in the State of Washington shall pass to the survivor without delay or expense in the event of the death of either party;

NOW, THEREFORE, we, FRED E. NYSTROM and L. YVONNE NYSTROM, husband and wife, for and in consideration of the love and affection which we have one for the other, do hereby mutually agree that all of the property which we now own Apparately, jointly or otherwise, and whether real, personal or otherwise, and situated in the State of Washington, shall be and it is hereby declared to be the community property of the parties, and each of the parties to this agreement does hereby convey and transfer to the other and to the community, all property owned by them in the State of Washington, even though the same be held in his or her separate estate; and

we hareby mutually agree that all of the property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatso-ever nature and situated in the State of Washington, shall be and it is hereby declared to be community property, and each of the parties does hereby convey and transfer to the other and to the community all such property hereafter acquired by either of them, even though the same be acquired in his or her separate estate; and

After acquired by us in the State of Washington, including all property the status of which is changed or created by this agreement, shall at once, in the event of the death of Fred E. Nystrom while the said L. Yvonne Nystrom survives, he vested in

IT IS FURTHER AGREED that this community property agreement shall pertain only to real and personal property situated in the State of Washington.
