Beginning at the southwest corner of the Southeast Quarter (SE<sup>1/4</sup>) of Section 17, Township 3 North, Range 8 E., W. M.; thence east 30 feet; thence north 716.8 feet; thence west 634.5 feet; thence north 934.5 feet to the initial point of the tract hereby described; thence west 172.5 feet; thence north 202.5 feet, more or less, to intersection with the south line of a tract of land conveyed to Jerry Carter and Mary Louise Carter, husband and wife, by deed dated July 8, 1970; thence east along said south line 172.5 feet to a point north of the initial point; thence south 202.5 feet, more or less, to the initial point;
