that portion of Lot 1, Block 2 Underwood Crest Addition, more particularly described as

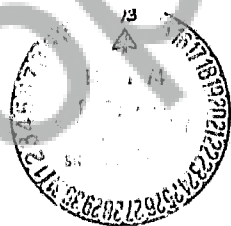
