DEDICATION DEED

GRANTOR(S) W. A. Stokes and Bertha I. Stokes, husband and wifefor and in consideration of the sum of Ten Dollars and other valuable considerations(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general publicwelfare, do by these presents grant, convey and dedicate to SKAMANIA County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA State of Washington:

A right of way as required for the reconstruction of the County Road known and designated Skye-Shields Road (County Road No. 1108) located in the S.W. 1/4 of the S.E. 1/4 and the S.E. 1/4 of the S.W. 1/4 of Section 19, Township 2 North, Range 5 E.W.M. in Skamania County, Washington.

More Particularly: A strip of land 30 feet in width lying easterly of and contiguous to the following described centerline from approximate Station 61 + 80 to approximate Station 65 + 10 being the south line of Grantors property.

A strip of land lying westerly of and contiguous to the following described centerline. Thirty feet in width from approximate Station 61 + 80 to approximate Station 63 + 70, thence tapering to 15 feet in width at approximate Station 65 + 10 being the south line of Grantors property.

CENTERLINE DESCRIPTION

Beginning at Station 57 + 25.56, said point being N 52° 0' W 3,344.54 feet from the southeast corner of Section 19, Township 2 North, Range 5 E.W.M., Skamania County, Washington. Station 64 + 25.69; thence following a 1,500 foot radius curve to the left 237.53 feet; thence S 1° 01' W 215.18 feet to P.C. Station 68 + 78.40; thence following a 450 foot radius curve to the left 56° feet; thence S 68° 12' 50" E 227.87 feet to Station 76 + 50 and end of pro-

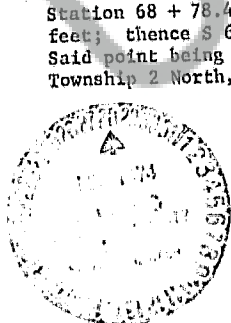
