(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to SKAMANIA County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of SKAMANIA State of Washington:

A right of way as required for the reconstruction of the County Road known and designated Skye-Shields Road (County Road No. 1108) located in the S.W.¼ of the S.E.¼ and the S.E.¼ of S.W.¼ of Section 19, Township 2 North, Range 5 E.W.M. in Skamania County, Washington

More Particularly: A strip of land 30 feet in width lying southerly of the following described centerline. From approximate Station 74 + 00 to approximate Station 76 + 10.

CENTERLINE DESCRIPTION

Beginning at Station 57 + 25.56, said point being N. 52° 0' W 3,344.54 feet from the Southeast corner of Section 19, Township 2 North, Range 5 E.W.M., Skamania County, Washington. Thence S. 0° 42' W 357.80 feet to P.C. Station 60 + 83.36; thence following a 1,500 foot radius curve to the right 245.80 feet; thence S. 10° 05' 20" W 96.53 feet to P.C. Station 64 + 25.69; thence following a 1,500 foot radius curve to the left 237.53 feet; thence S. 1° 01' W 215.16 feet to P.C. Station 68 + 78.40; thence following a 450 foot radius curve to the left 543.23 feet; thence S. 68° 12' 50" E 227.87 feet to Station 76 + 50 and end of project. Said point being N. 79° 44' W 2,247.89' from the Southeast corner of Section 19, Township 2 North, Range 5 E.W.M., Skamania County, Washington.
