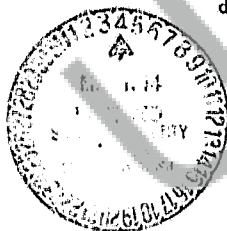
THE GRANTOR , LONNA DEE GUNDERSEN, dealing with her separate property,
