

REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this 15th day of March 1974 between Frank Dale Hatch and Mina E. Hatch, husband & wife

hereinafter called the "seller," and Myrtle L. Young, a single woman

hereinafter called the "purchaser,"

WITNESSETH: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamania County, State of Washington:

A tract of land located in the Northwest Quarter of the Northwest Quarter (NW 1/4 NW 1/4) of Section 34, Township 2 North, Range 53 W.M., described as follows:

Beginning at the southeast corner of the NW 1/4 of the said Section 34; thence north 00°40'49" west along the east line of said subdivision 454.74 feet; thence south 77°12'20" west 51.40 feet to a point on the south line of said driveway 291.95 feet to the initial point of the tract hereby described; thence south 77°12'20" west along the south line of said driveway 447 feet; thence south 08°06'30" east 172.32 feet to the northerly right of way line of County Road No. 1106 designated as the Washougal River Road; thence northeasterly along the northerly right of way line of said Washougal River Road to a point south 08°06'30" east from the initial point; thence north 08°06'30" west to the initial point.

Together with an undivided 1/2 interest in the water pipeline easement and water storage tank acquired by the seller by deed dated 2/29/72 and recorded at page 809 of Book 63 of Deeds recorded in Skamania County, Washington.

This property also to include 1971, 12' x 60' Pacifica Mobile Home serial No. 11341.

Also together with and subject to an easement for road purposes described in deed #74486, Book 63, page 809, in records in Skamania County.

at the rate of (8) eight per cent per annum from the 15th day of March which interest shall be deducted from each installment payment and the balance of each payment applied in reduction of principal. All payments to be made hereunder shall be made at PACIFIC NAT. BK. OF WASHINGTON or at such other place as the seller may direct in writing. WASHOUGAL BR. This contract to be paid out in full on or before March 15, 1984.

The above stated purchase price of \$14,500.00 represents land value at the sale price of \$9,540.00 and personal property at the sale price of \$4,960.00.

As referred to in this contract, "date of closing" shall be March 15, 1974 Amount Paid 9,540 Skamania County Treasurer

- (1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may be levied on said real estate... (2) The purchaser agrees, until the purchase price is fully paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against loss or damage by fire and windstorm... (3) The purchaser agrees that full inspection of said real estate has been made and that neither the seller nor his assigns shall be held to any covenant... (4) The purchaser assumes all hazards of damage to or destruction of any improvements now on said real estate... (5) The seller has delivered, or agrees to deliver, within 15 days of the date of closing, a purchaser's policy of title insurance...

(6) Seller's title to said real estate is subject to existing covenants, conditions or restrictions under which seller is purchase of said real estate in any way, or other obligation, which seller has to pay, seller agrees to make such payments in accordance with the terms hereof, and upon default, the purchaser shall have the right to make any payment necessary to remove the default, and any payment so made shall be applied to the payment of next falling due of seller under this contract.

(7) The seller agrees, upon receiving full payment of the purchase price and interest in the manner above specified, to execute and deliver to purchaser a statutory warranty deed to said real estate, except any part thereof heretofore taken for public use, free of encumbrances except any that may attach after date of closing through any person other than the seller, and subject to the following:

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said real estate on date of closing and to retain possession so long as purchaser is not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to use, or permit the use of, the real estate for any illegal purpose. The purchaser covenants to pay all service, installation or construction charges for water, sewer, electricity, garbage or other utility services furnished to said real estate after the date purchaser is entitled to possession.

(9) In case the purchaser fails to make any payment herein provided or to maintain insurance, as herein required, the seller may make such payment or effect such insurance, and any amounts so paid by the seller, together with interest at the rate of 10% per annum thereon from date of payment until repaid, shall be repayable by purchaser on seller's demand, all without prejudice to any other right the seller might have by reason of such default.

(10) Time is of the essence of this contract, and it is agreed that in case the purchaser shall fail to comply with or perform any condition or agreement hereof or to make any payment required hereunder promptly at the time and in the manner herein required, the seller may elect to declare all the purchaser's rights hereunder terminated, and upon his doing so, all payments made by the purchaser hereunder and all improvements placed upon the real estate shall be forfeited to the seller as liquidated damages, and the seller shall have right to re-enter and take possession of the real estate; and no waiver by the seller of any default on the part of the purchaser shall be construed as a waiver of any subsequent default.

Service upon purchaser of all demands, notices or other papers with respect to forfeiture and termination of purchaser's rights may be made by United States Mail, postage pre-paid, return receipt requested, directed to the purchaser at his address last known to the seller.

(11) Upon seller's election to bring suit to enforce any covenant of this contract, including suit to collect any payment required hereunder, the purchaser agrees to pay a reasonable sum as attorney's fees and all costs and expenses in connection with such suit, which sums shall be included in any judgment or decree entered in such suit.

If the seller shall bring suit to procure an adjudication of the termination of the purchaser's rights hereunder, and judgment is so entered, the purchaser agrees to pay a reasonable sum as attorney's fees and all costs and expenses in connection with such suit, and also the reasonable cost of searching records to determine the condition of title at the date such suit is commenced, which sums shall be included in any judgment or decree entered in such suit.

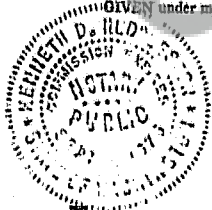
