## DEDICATION DEED

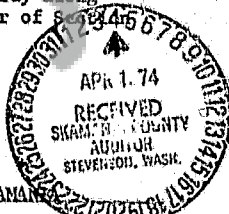

GRANTOR(S) Otto T. Scherpf and Winnifred T. Scherpf, husband & wife  
 for and in consideration of the sum of Ten Dollars and other valuable considerations  
 (\$ 10.00 ) Dollars, to us in hand paid, and in further consideration of the general public  
 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,  
 State of Washington, for the use of the public as a county road and appurtenances the following de-  
 scribed real property in the County of SKAMANIA State of Washington:

A right of way for the reconstruction of the County Road known and designated  
 as Martin Road (County Road No. 1124) located in the southwest one quarter of  
 Section 6, Township 1 North, Range 5 E.W.M. in Skamania County, Washington, more  
 particularly described as follows:

Commencing at the South one quarter corner of said Section 6; thence N 0° 40'  
 09" W 1,370.37 feet to southeast corner of Lot No. 1, Silver Star Acres, said point  
 being true point of beginning; thence West 24 feet; thence S 0° 40' 09" E 650 feet;  
 thence S 45° W 60 feet more or less to the intersection of the North right of way  
 line of Belle Center Road (1974 Reconstruction Project); thence easterly along  
 said right of way line to it's intersection with the North-South center of S 24 1/2  
 line of said Section 6; thence N 0° 40' 09" W to point of beginning.

Consisting of a total of 0.46 acres  
 less existing rights of way being a  
 net acreage of 0.40 acres more or less.
