 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,  
 State of Washington, for the use of the public as a county road and appurtenances the following de-  
 scribed real property in the County of SKAMANIA, State of Washington:

A right of way as required for the reconstruction of the County Road known  
 and designated Marrin-Didier Road (County Road No. 1125) located in the S.W. 1/4 of  
 Section 6, Township 1 North, Range 5 E.W.M. in Skamania County, Washington.

More particularly: A strip of land 75 feet in width lying westerly of and  
 contiguous to the following described centerline from approximate Station 0 + 30  
 to approximate Station 2 + 00; thence 50 feet in width to approximate Station  
 3 + 00.

#### CENTERLINE DESCRIPTION

Commencing at P.C. Station 166 + 61.97 on Belle Center Road; thence  
 S 14° 35' 01" W 50.53 feet to the P.C. of a 300 foot radius curve to the  
 right 196.31 feet distant to P.T. Station 2 + 46.83; thence S 52° 04' 31" W  
 53.17 feet to Station 3 + 00.


