Also, reserving to the vendor, or his tenant now in possession of the property, in consideration of the protection and maintenance of the land, to which the vendor hereby agrees, reserves the right to occupy until 20 March 1975 that portion of the lands herein described upon which said buildings and improvements are now situated.
