in hand paid, conveys and warrants to DANNIE G. TRUELOVE and CYNTHIA D. TRUELOVE, husband and wife,

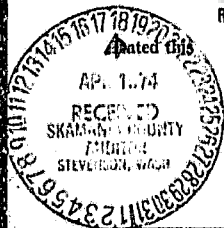
the following described real estate, situated in the County of Skamania, State of Washington:

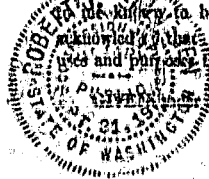
