(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to Skamania County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of Skamania, State of Washington:

A right of way for the reconstruction of the County Road known and designated as Martin Road (County Road No. 1124) located in the southwest one quarter of Section 6, Township 1 North, Range 5 E.W.M. in Skamania County, Washington, more particularly described as follows:

The west 13 feet parallel to and along the north 200' et of the following described property:

A parcel of land being the west one half of the west one half of the southwest one quarter of the southeast one quarter of Section 6, Township 1 North, Range 5 E.W.M. less the north 462 feet and the south 264 feet of said parcel.

Consisting of a total of 0.06 acres more or less.
