14 said Agreement; and

15 It is intended that the statements set forth herein shall
16 be considered representations of fact which may be relied upon by
17 all persons dealing with the following described real and personal

Parcel I:

21 Commencing at the southwest corner of the northwest quarter
22 of the southeast quarter of Section 25, Township 3 North,

25 northerly along said road 250 feet; thence west to the west
26 line of the northwest quarter of the southeast quarter of
27 the said Section 25; thence south along said west line to
