


RELEASE OF TIMBER CONTRACTS
FROM BOISE CASCADE CORPORATION, AS SUCCESSOR IN INTEREST
TO BOISE CASCADE PAPER CORPORATION, TO BOISE CASCADE CORPORATION

WHEREAS, Boise Cascade Corporation is the Successor in interest to Boise Cascade Paper Corporation, a Delaware corporation, by reason of a merger of the two companies duly executed on October 7, 1964 and recorded in Deed Records Book 53, page 403 of Skamania County, Washington.

WHEREAS, prior to said merger Boise Cascade Corporation and Boise Cascade Paper Corporation did enter into certain contracts whereby Boise Cascade Corporation granted Boise Cascade Paper Corporation timber cutting rights on certain lands in this county and such contracts were recorded;

WHEREAS, despite the recordation of merger previously referred to, certain of these contracts have shown up as clouds on the title of Boise Cascade Corporation or third parties claiming title as successors in interest to Boise Cascade Corporation;

BOISE CASCADE CORPORATION this 10th day of October, 1973, acting as successor in interest to Boise Cascade Paper Corporation, does hereby release all claim of right it may have against all properties specified in the above-mentioned timber contracts, and all subsequent amendments thereof, from Boise Cascade Corporation to Boise Cascade Paper Corporation. Such



release is to operate in favor of Boise Cascade Corporation and all persons claiming as successors in interest to Boise Cascade Corporation.

SATISFACTION AND DISCHARGE OF MORTGAGE

March 10, 1965

1. THE CHASE MANHATTAN BANK, NEW YORK, is Trustee under a certain Indenture of Trust between BOISE CASCADE PAPER CORPORATION, a Delaware corporation, and said Trustee, dated as of July 12, 1962, pursuant to which Boise Cascade Paper Corporation issued certain Secured Notes evidencing indebtedness.

2. As security for such indebtedness, Boise Cascade Paper Corporation, as mortgagor, made a Chattel Mortgage, dated as of July 12, 1962, to The Chase Manhattan Bank, as Trustee under the above-mentioned Indenture of Trust. Said Chattel Mortgage was recorded in the records of real property and cross-indexed in the chattel mortgage records of two Oregon counties as follows:

An assignment and consent dated as of July 12, 1962, of a certain power cutting contract between Boise Cascade Paper Corporation (Seller) and Boise Cascade Corporation (Buyer), dated July 9, 1962, and assignment and consent deeds from Boise Cascade Paper Corporation to The Chase Manhattan Bank, as Trustee, as further security for such indebtedness, was recorded in the records of real property and cross-indexed in the records of chattels in the following nine Oregon counties:
