GRANTOR(S) Louie and Alice Anker, husband and wife 77702

welfare, do by these presents grant, convey and dedicate to SKAMANIA County,

State of Washington for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA, State of Washington:

A right of way as required for the County Road known and designated Lakeview Road (County Road No. 3001) located in Government Lot No. 4, Section 2, Township 3 North, Range 16 East W.M., in Skamania County, Washington, more particularly described as follows:

A strip of land sixty (60) feet in width lying northerly of and contiguous to the south line of Government Lot No. 4 of Section 2; Beginning at a point on the south line of Government Lot No. 4, said point lying 330 feet easterly from the southwest corner of said Government Lot No. 4; thence running easterly 330 feet along said south line of Government Lot No. 4 to easterly boundary of grantors real property as described in deed dated March 21, 1973, and recorded at Page 83, Book 65 of Deed, records of Skamania County.

Containing 0.45 acres more or less.

I HAVE AND TO HOLD the said described premises unto the said SKAMANIA

County and its successor or successors for the use of the public forever.
