
A right of way as required for the County Road known and designated Lakeview Road (County Road No. 3001) located in Government Lot No. 4, Section 2, Township 3 North, Range 1C East W.M., in Skamania County, Washington, more particularly described as follows:

A strip of land sixty (60) feet in width lying northerly of and contiguous to the south line of Government Lot No. 4 of Section 2; Beginning at a point on the south line of Government Lot No. 4, said point lying 330 feet easterly from the southwest corner of said Government Lot No. 4; thence running easterly 330 feet along said south line of Government Lot No. 4 to easterly boundary of grantors real property as described in deed dated March 21, 1973, and recorded at Page 83, Book 63 of Deed, records of Skamania County.
