 (\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public
 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
 State of Washington, for the use of the public as a county road and appurtenances the following de-
 scribed real property in the County of SKAMANIA State of Washington:

A right of way as required for the reconstruction of the County Road
 known and designated School House Road (County Road No. 3371) located in the
 N.E. 1/4 of Section 21, Township 3 North, Range 10 E.W.M. in Skamania County,
 Washington

More Particuarly: That portion of the following described right of way
 lying below the North line of the S.W. 1/4 of the N.E. 1/4 of Section 21, Township 3
 North, Range 10 E.W.M.

A strip of land 30 feet in width lying southerly of and contiguous to the
 following described centerline from approximate Sta. 9 + 28 to Sta. 13 + 51.34.

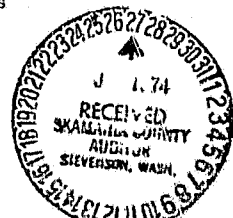
Beginning at Engineers Station 0 + 00, said point lying S 53° 8' 48" W

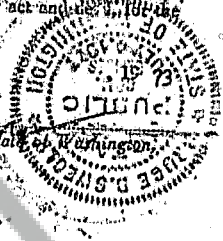
