REAL ESTATE CONTRACT

THIS CONTRACT, made and entered into this

6 h day of August 1974

between JOHN N. SKIMAS and JOANNE M. SKIMAS, husband and wife,

hereinafter called the "seller," and John McGUIRE and STELLA McGUIRE, husband and wife,

hereinafter called the "purchaser,"

WITNESSLIFE: That the seller agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances, in Skamania County, State of Washington:

Lot twelve (12), Silver Star Addition, according to the duly recorded plat therof in Book 64 of Deeds, page 167, records lof Skamania County.

Subject to easements and restrictions of record.

Subject to easement for electric and tlelphone transmission lines across the South five (5) feet thereof.

Note: All access roads to the property are County Roads and Sellers are not responsible for their maintenance. The terms and conditions of this contract are as follows: The purchase price is

- ^{(\$} 5,000.00) Dollars, of which Five thousand and no7100 ----Five hundred of a total view nine and 12/100 589-12 7.26,5% Dollars have over paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows:

Not less than seventy-five \$(75.00) per month commencing on June 1, 1974 and a like amount on the first day of each month thereafter, until the balance of the purchase price is fully paid together with interest thereon at the rate of eight (8%) per annum. From each payment shall first be deducted the interest to date and the remainder applied on principal.

Real property taxes for 1974 will be paid in full by seller and purchaser agrees to reimburse seller \$ within 90 days hereof.

This agreement supercedes any prior agreements of the parties.

All payments to be made bereumier shall be made at 502 Umatilla Way Vancouver, Wash. 98661 or at such other place as the relier may direct in writing.

As referred to in this contract, "date of closing" shall be May 1 . 1974

- (1) The purchaser assumes and agrees to pay before delinquency all laxes and assessments that may as between granter and grantee hereafter Ectorie a hen in said real estate; and if by the terms of this contract the purchaser has assumed payment of any mortgage, contract or other encumbrators, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.
- (2) The purchaser are grees, until the purchase price is follo paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against loss or damage by both fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his intenst may appear, and to pay all premiums therefor and to deliver all rollicies and renewals thereof to

 (3) The purchaser agrees that full inspection of said real estate has been made and that neither the seller nor his assigns shall be held to any covenant respecting the condition of any improvements thereon nor shall the purchaser or seller or the assigns of either be held to any covenant or agreement for alterations, improvements or repairs unless the covenant or agreement relied on is contained herein or is in writhing and attached to and made a part of this contact the validability of water has not been represented.

 (4) The purchaser assumes all hazards of damage to or destruction of any improvements now on said real estate or hereiter placed thereon, and of the taking of said real estate or any part thereof for public use; and agree, that no such damage, destruction or saking shall constitute a failure of consideration. In case any part of said real estate is taken for public use, the portion of the condemnation award remaining after payment of reasonable expenses of procuring the same shall be paid to the seller and applied as payment on the purchase price herein unless the seller elects to allow the nurther of outply all or a portion of such condemnation award to the rebuilding or restoration of any improvements dumared by such taking. - b. Liens or encumbrances which by the terms of this contract the purchaser is to assume, or as to which the conveyance hereunder is to be made subject; and
- c. Any existing contract or contracts under which seller is purcharing said real estate, and any mortgage or other obligation, which seller by this contract agrees to pay, none of which for the purpose of this paragraph (5) shall be deemed defects in seller's title.

(6) If seller's title to said real ate is subject to an existing contract or contracts under which seller is purchasing said real estate, or any mortgage or other obligation, which seller is to pay, seller agrees to make such payments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payments necessary to remove the default, and any payments so made shall be applied to the payments next falling due the seller under this contract,

(7) The seller agrees, upon receiving full payment of the purchase price and interest in the manner above specified, to execute and deliver to purchaser a statutory warranty deed to said real estate, excepting any part thereof hereafter taken for public use, free of encumbrances except any that may attach after date of closing through any part that the seller, and subject to the following: deed to said real estate, excepting any part thereof hereafter

(8) Unless a different date is provided for herein, the purchaser shall be entitled to possession of said rea, estate on date of closing and to retain possession so long as purchaser is not in default hereunder. The purchaser covenants to keep the buildings and other improvements on said real estate in good repair and not to permit waste and not to use, or permit the use of, the teal estate for any illegal services irratished to said real estate after the date purchaser is entitled to possession.

(9) In case the purchaser fails to make any payment herein provided or to maintain insurance, as herein required, the seller may make such payment or effect such insurance, and any amounts so paid by the seller, together with interest at the rate of 10% per annum thereon might have by reason of such default.

(10) Time is of tre essence of this contract, and it is agreed that in case the purchaser shall fall to comply with or perform any seller may elect to declare all the purchaser is rights hereunder terminated, and upon his doing so, all payments made by the purchaser have right to re-enter and take possession of the real estate shall be forfeited to the seller as liquidated damages, and the seller have right to re-enter and take possession of the real estate, and no waiver by the seller of any default on the part of the purchaser shall be construed as a waiver of any subsequent default.
