(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public
welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
State of Washington, for the use of the public as a county road and appurtenances the following de-
scribed real property in the County of SKAMANIA, State of Washington:

RIGHT OF WAY DESCRIPTION

Beginning at a point 520 feet North of the S.W. corner of the S.E. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 21, Township 3 North, Range 8 E.W.M. Said point being on the West line of the S.E. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 21. Thence East 30 feet; thence North to a point 50 feet South of the North line of the S.E. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 21; thence West 30 feet; thence South to point of beginning.

Beginning at a point 496 feet North of the Southeast corner of the S.W. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 21, Township 3 North, Range 8 E.W.M. Said point being on the East line of the S.W. $\frac{1}{4}$ of the N.W. $\frac{1}{4}$ of Section 21; thence West 30 feet; thence North 409 feet; thence East 30 feet; thence South to point of beginning.
