RIGHT OF WAY DESCRIPTION

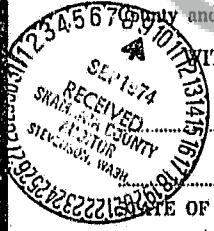
Beginning at a point 1,000.67 feet east and 1,680.00 feet north of the
