(1) The purchaser assumes and agrees to pay before delinquency all taxes and assessments that may as between against and grantee hereafter become a lien on said real estate; and if by the terms of this contract the purchaser has assumed payment of any mortage, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lien on taid real estate, the purchaser agrees to pay the same before delinquency.
