

## TELEVISION CABLE EASEMENT

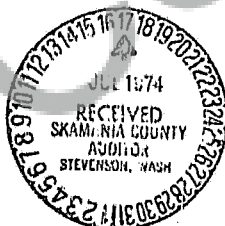

SEAGER, doing business as GORGE CABLE-VISION, an easement and right of way 6 feet in width for a cable television line to be buried 18 inches below the surface of the ground, and the right to repair and maintain the same, over and across the following described real property in Skamania County, Washington:

The southerly 6 feet of Lots 37, 38, 39, 40 and 41 of COLUMBIA HEIGHTS according to the official plat thereof on file and of record at page 136 of Book A of Plats, Records of Skamania County, Washington; and

The northerly 6 feet of Lots 43, 44, 45, 46, 47 and 48 of COLUMBIA HEIGHTS according to the official plat thereof on file and of record at page 136 of Book A of Plats, Records of Skamania County, Washington.
