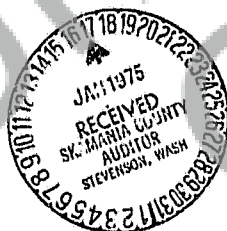

All that portion of the following described tract of land lying above elevation 72.00 feet Mean Sea Level and below elevation 82.20 feet Mean Sea Level situated in the Southwest quarter of Section 11, Township 2 North, Range 7 East of the Willamette Meridian, Skamania County, Washington:

Beginning at a point 116.00 feet Southerly from the Northwestern corner on the Westerly line of the D. F.
