## RIAL ESTATE CONTRACT

THIS CONTRACT, made and entered byto this 26th day of December, 1974

NORMAN S. GARWOOD and HAZEL S. GARWOOD, husband and wife,

hereinafter called the "coller," and FATTH TABERNACLE OPEN DIBLE CTANDARD CHURCH, a non-prof 42110 corporation.

WITNESSETH: That the relier agrees to sell to the purchaser and the purchaser agrees to purchase from the seller the following described real estate, with the appurtenances in Skamarria County, State of Washingtons

Ligjett as Trustee by deed dated April 16, 1948, and recorded at page 35 of Book 32 of Deeds.

The terms and conditions if this contract are as follows: The purchase price is Sixteen Thousand and No/100 (# 16,000.00 ) Dollars, of which Three Thousand and No/100 -(\$3,000.00 ) Dollars have been paid, the receipt whereof is hereby acknowledged, and the balance of said purchase price shall be paid as follows:

The purchaser agrees to pay the balance of the purchase price in the sum of Thirteen Thousand and No/100 (\$33,000.00) Dollars in monthly installments of One Hundred Fifty and No/100 (\$150.00) Doillars commencing on the first day of February, 1975, and on the first day of each and every month thereafter until the full amount of the purchase price together with interest shall have been paid. The said monthly installments shall include interest at the rate of nine percent (9%) per annum computed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. Furchaser agrees to make no larger month specified above except with the express written consent of the sex

(1) The purchaser assumes and agries to pay before delinquency all taxes and assessments that may as between granter and grantee hereafter become a lien on said real estite; and if by the terms of this contract the purchaser has assumed payment of any mortgage, contract or other encumbrance, or has assumed payment of or agreed to purchase subject to, any taxes or assessments now a lien on said real estate, the purchaser agrees to pay the same before delinquency.

(2) The purchaser agrees, until the purchase price is fully paid, to keep the buildings now and hereafter placed on said real estate insured to the actual cash value thereof against loss or damage by in the fire and windstorm in a company acceptable to the seller and for the seller's benefit, as his interest may uppear, and to pay all premiums therefor and to deliver all policies and renewals thereof to

(3) The purchaser agrees that full inspection of said real estate has been made and that reither the seller nor his assigns shall be held to any covenant respecting the condition of any improvements thereon nor shall the purchaser or seller or the assigns of either be held to any covenant or agreement for alterations, improvements or repairs unless the covenant or agreement relied on its contained herein or is in writing and attracted to and made a part of this contract.
