

COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT, made this day by and between FRITZ W. TIETZ and VELMA I. TIETZ, husband and wife, both of Skamania County, Washington,

W I T N E S S E T H:

That whereas said FRITZ W. TIETZ and VELMA I. TIETZ are the owners of certain community and separate property, and whereas all of the property now owned, or which shall come into the possession of either hereafter, is hereby declared to be the community property of the said FRITZ W. TIETZ and VELMA I. TIETZ, and whereas said parties are desirous of providing for the disposition of said property upon the death of either, under and by virtue of and in conformity with the provisions of Section 26.16.120, Revised Code of Washington, (R.R.S. 6894), and to provide that said property and all property of which either may die possessed, both real and personal and wherever situate, shall pass without delay or expense in case of the death of either of the said parties to the survivor;

NOW, THEREFORE, in consideration of the love and affection that each of said parties has for the other, IT IS HEREBY AGREED:

I.

That all property now owned by the parties hereto, or by either of them, whether separate or community, is hereby conveyed and converted into community property and hereafter shall be deemed community property for all purposes under the laws of the State of Washington.

II.

That in case of the death of the said FRITZ W. TIETZ, while the said VELMA I. TIETZ survives, the whole of the said property hereinbefore described, together with any other property by them hereafter acquired, shall at once vest in the said VELMA I. TIETZ, in fee simple, as her sole and separate property; and in case of the death of the said VELMA I. TIETZ, leaving the said FRITZ W. TIETZ surviving, the whole of said property hereinbefore described, to-

gether with any other property by them hereafter acquired, shall at once vest in the said FRITZ W. TIETZ, in fee simple, as his sole and separate property.
