

1 DECLARATION OF HOMESTEAD

2 STATE OF WASHINGTON)
3 COUNTY OF CLARK) ss.

4 KNOW ALL MEN BY THESE PRESENTS, That HOWARD JAMES HEGLIN
5 and JUDITH LEE HEGLIN, husband and wife, who reside at Route 2, Box
6 2370, Washougal, Washington, that they are the identical persons
7 making this Declaration of Homestead.

8 That they reside at Washougal, Washington, and that they
9 own in their own right the following described real property:

10 Located in Skamania County, State of Washington, to-wit:

11 A tract of land located in the Northwest Quarter of the
12 Northeast Quarter of Section 30, Township 2 North,
13 Range 5 E.W.M., more particularly described as follows:
14 BEGINNING at a point on the south line of an existing
15 county road 300 feet South of the northwest corner of
16 the NW1/4 of the NE1/4 of the said Section 30; thence
17 east along the south line of said county road 209 feet;
18 thence south 627 feet; thence west 209 feet to the west
19 line of the NE1/4 of the said Section 30; thence north
20 627 feet to the point of beginning; EXCEPT that portion
21 thereof lying within the 300 foot strip of land acquired
22 by the United States of America for the Bonneville Power
23 Administration's electric power transmission lines;
24 TOGETHER WITH an easement for a water pipeline from the
25 above described tract to a certain spring located in
26 the Southwest Quarter of the Southeast Quarter of Section
27 19, Township 2 North, Range 5 E.W.M., said easement
28 being more particularly described in deed dated May 31,
29 1911, and recorded June 17, 1911, at page 196 of Book N
30 of Deeds, Records of Skamania County, Washington;
31 ALSO: The following described tract of land located in
32 the Southwest Quarter of the Southeast Quarter of Section
19, Township 2 North, Range 5 E.W.M., more particularly
described as follows:
BEGINNING at the quarter corner on the south line of the
said Section 19; thence north 509.5 feet; thence east
272.1 feet to the initial point of the tract hereby
described; thence south 69°02' east 208.75 feet; thence
south 20°58' west 208.75 feet; thence north 69°02' west
208.75 feet; thence North 20°58' east 208.75 feet to
the initial point.

That the premises owned by these parties is used exclusively
for a home and dwelling house by the parties and which property will
not be devoted exclusively to any other purpose and that the value
thereof does not exceed \$10,000.00, exclusive of any mortgages,
mechanics' or materialmen's liens.
