

TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT is made this 3rd day of January 1975, by the UNITED STATES OF AMERICA, through the Acting Regional Forester, Forest Service, Department of Agriculture, hereinafter referred to as "Government," and Burlington Northern Inc., successor in interest by merger to Northern Pacific Railway Co., hereinafter referred to as "Cooperator."

WHEREAS, Cooperator by Deed dated March 15, 1963, recorded in Skamania County, Washington, Deed Records at Book 51, page 236, did grant and convey unto Government an Easement for the Spirit Lake-Iron Creek Road No. 100 over the following described lands of Cooperator:

T. 9 N., R. 5 E., W.M.
Section 13, lot 7

WHEREAS, the Government subsequently acquired title to the above described lands and additional lands from the Cooperator by Land Exchange Deed dated April 1, 1971.

WHEREAS, both Government and Cooperator do intend and agree that the Deed subsequently granted shall supersede the aforesaid Easement dated March 15, 1963, and shall govern and control the rights of Government and Cooperator for use of the lands and the roads thereon subject to such subsequent Deed.

ew NOW, THEREFORE, the Cooperator and Government hereby release and relinquish all rights in the Spirit Lake-Iron Creek Road No. 100 created by and arising from or out of the aforesaid Easement dated March 15, 1963, it being intended to cancel said Easement.

THIS TERMINATION OF EASEMENT shall, however, have no effect on the rights granted to Government by the Land Exchange Deed dated April 1, 1971, all the terms, provisions and conditions of which shall remain and be fully effective.

IN WITNESS WHEREOF, the Government, through the Acting Regional Forester, Forest Service and Cooperator, by its duly authorized officers have executed this Termination of Easement on the day and year first above written.

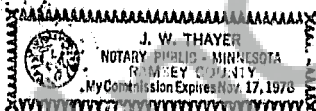
