## COMMUNITY PROPERTY AGREEMENT

This COMMUNITY PROPERTY AGREEMENT entered into this date between PAUL E. KESSEL and J. ERNESTING KESSEL, husband and wife, both of Skamania County, State of Washington:

## WITNESSETHE

WHEREAS, the parties hereto are the owners of certain real and personal property situate in the State of Washington, and

Kessel survives, then the whole of the community property now owned by us or hereafter acquiredby us, including all property the status of which is changed or created by this agreement, shall at once west in the said PAUL E. KESSEL, absolutely and in fee simple as his sole and separate property.
