Macdonald, husband and wife, for and in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, the receipt of which is hereby acknowledged, does hereby convey and quit claim unto Knappton Towboat Company, a Washington corporation, hereinafter called the grantee, and unto grantee's successors and assigns, all of their right, title and interest in and to that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Skamania, State of Washington, described as follows, to with

Commencing in Section 29, Township 2 North of Range 7 East of the Willamette Meridian, at a point in the line dividing the Donation Land Claim of the said S. M. Hamilton and George W. Johnson, which point is ascertained by running from the present intersection of the center line of the railroad now in use with the said dividing line between said Donation Land Claim, a line North 27°, West 240 feet in length and from the Northern point of said line running a line North 18° East until it shall intersect said dividing line between said donation land claim, which said intersection last aforesaid is the initial point of this description; running from thence South 18° West 2300 feet more or less to the Northern boundary line of land heretofore on the 27th of July, 1363, conveyed by the said S. M. Hamilton and wife to the said "Cascade Railroad Company", the said line intended to run parallel with the general cour of the part of the present line of the railroad and 240 feet distant therefrom; thence Westerly along the northern boundary line of said land as just hereinbefore referred to as conveyed by said S.
