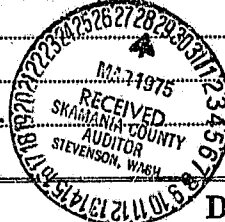

DEDICATION DEED

GRANTOR(S) William R. Ingels and Joyce Ingels, husband & wife

for and in consideration of the sum of One Dollar and other valuable consideration
 (\$1.00) Dollars, to us in hand paid, and in further consideration of the general public
 welfare, do by these presents grant, convey and dedicate to SKAMANIA County,
 State of Washington, for the use of the public as a county road and appurtenances the following de-
 scribed real property in the County of SKAMANIA, State of Washington:

A right of way as required for the County Road known and designated Lakeview
 Road (County Road No. 3001) located in Government Lot No. 1, Section 3 and in
 Government Lot No. 4, Section 2, Township 3 North, Range 10 E.W.M. in Skamania
 County, Washington, more particularly described as follows:

A strip of land 30 feet on either side of centerline of Lakeview Road which
 passes through property owned by Ingel, said parcel of land including the exist-
 ing County Road right of way plus that amount hereinabove described, being a total
 of 0.50 of an acre more or less.

This deed will be amended to include the exact surveyed description upon the
 completion of the County Road survey now underway. This survey is scheduled to be
 completed in 1976.

TO HAVE AND TO HOLD the said described premises unto the said SKAMANIA
 County and its successor or successors for the use of the public forever.
