A right of way for the reconstruction of County Road known and designated as the Shipherd Falls Road (County Road No. 22840) located in Skamania County, Washington more particularly described as follows:

Commencing at a point 2,350 feet North of the Southwest corner of the Northwest one quarter of the Southwest one quarter of Section 21, Township 3 North, Range 8 E.W.M. Thence East 1,329 feet to a point hereafter referred to as the point of beginning; thence North 336.25 feet; thence West 25 feet; thence South 336.25 feet; thence East 25 feet to point of beginning.

Said right of way being a total of 0.18 of an acre more or less, inclusive of a former easement for Shipherd Falls Road, for the East 15 feet of the above described parcel of land.
