IN THE MATTER OF SR 14 (formerly Primary State Highway No. 8), Prindle
to Skamania Pit and Stockpile Sites

KNOW ALL MEN BY THESE PRESENTS, that THE STATE OF WASHINGTON, for
and in consideration of clearing title, hereby conveys and quitclaims
unto DONALD G. MAC KAY and ARCH MAC DONALD, all its right, title and
interest, in and to the following described real property situated in
Skamania County, State of Washington:

A perpetual easement and right of way for a haul road, the centerline
of which is described in Volume 32 of Deeds at page 316, under
Auditor's File No. 38985, and more particularly described as follows:

Commencing at the Northeast corner of the E. C. Hardy Donation Land
Claim No. 41 on the Section line between Sections 19 and 30, Town-
ship 2 North, Range 7 East, W.M., approximately 281.8 feet Westerly
from the Section corner common to Section 19, 20, 29 and 30 in said
Township and Range; running thence South 54°32' East a distance of
1040.5 feet to the initial point of the haul road being herein
described; thence North 33°58'30" East 326.9 feet; thence North
49°32'30" East 257.5 feet; thence North 23°47'30" East 1649.4 feet;
thence North 58°38'30" East 314.5 feet to a point distant 15 feet
Southerly from the Southerly right of way line of the Spokane,
Portland and Seattle Railroad at Railroad Engineer's Station
1971+02.3; thence Easterly, parallel with said railroad right of
way line and 15 feet distant Southerly therefrom, to a point 15
feet distant Westerly from the East line of the S. M. Hamilton
Donation Land Claim No. 40; thence Northwesterly, parallel with
said S. M. Hamilton Donation Land Claim line and 15 feet distant
Westerly therefrom to Primary State Highway No. 8 and the end of
this description.

that certain map of definite location now of record and on file in the
Office of the Director of Highways at Olympia, Washington, bearing date
of approval October 8, 1948, revised February 4, 1949.

The lands herein described are not required for State highway
