GRANTOR(S) Frederick D. Morgan, a single manRoyal A. Ivory and B. Harriet Ivory, husband & wifefor and in consideration of the sum of Ten Dollars and other valuable considerations

(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to SKAMANIA County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of SKAMANIA, State of Washington:

RIGHT OF WAY DESCRIPTION

A right of way for the reconstruction of the County Road known and designated as Tote Road (County Road No. 121 60) located in Section 27, Township 2 North, Range 5 E.W.M. in Skamania County, Washington described as follows:

Parcel No. 1

A strip of land 30 feet in width on the left of, parallel and contiguous to the following described centerline from approximate Station 0 + 38 to Station 5 + 50.

Parcel No. 2

A strip of land of varying width lying to the right of and contiguous to the following described centerline bounded on the East by the westerly right of way line of the Washougal River Road, approximate Station 0 + 52 to approximate Station 2 + 70; thence 50 feet in width to Station 3 + 00; thence 30 feet in width to Station 5 + 50.

CENTERLINE DESCRIPTION

Beginning at Engineers Station 0 + 00 on Tote Road equals P.C. Station 229 + 53.60 of Washougal River Road. Said point being S 0° 17' 30" E 871.52 feet from the Northeast corner of Section 27, Township 2 North, Range 5 E.W.M.; thence N 66° 16' 52" W 18.26 feet to the P.C. of a 50 foot radius curve to the right. Thence along said curve 56.56 feet to P.T. Station 0 + 79.82; thence N 1° 27' 47" W 168.48 feet to the P.C. of a 75 foot radius curve to the left; thence along said curve 180.72 feet to P.T. Station 4 + 24.02; thence S 40° 28' 24" W 125.08 feet to Station 5 + 50. Said Station being S 20° 23' 9" W 747.10 feet from Northeast corner of Section 27, Township 2 North, Range 5 E.W.M.

Consisting of a total acreage of 0.75 acres less existing rights of way for a net acreage of 0.48 acre more or less.

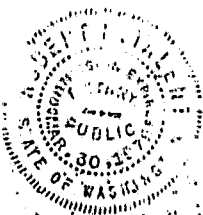
