(\$1.00) Dollars, to us in hand paid, and in further consideration of the general public welfare, do by these presents grant, convey and dedicate to SKAMANIA County, State of Washington, for the use of the public as a county road and appurtenances the following described real property in the County of SKAMANIA, State of Washington:

For a right of way for the extension of Snider Barks Road, said right of way being 30 feet on either side of the following described centerline located in the Southeast one quarter of Section 36, Township 2 North, Range 5 E.W.M. in Skamania County, Washington.

Starting at a point in the center of the Snider Barks Road (County Road No. 12140) at it's intersection with the East section line of Section 36 as marked by an iron rod.

Thence N 59° 34' 30" W 257 feet more or less
Thence N 40° 09' 33" W 127.40 feet,
Thence N 67° 12' 18" W 247.91 feet,
Thence N 06° 09' 48" W 167.83 feet,
Thence N 49° 35' 57" W 169.09 feet,
Thence N 09° 23' 24" W 147.98 feet,
Thence N 44° 13' 57" W 40 feet more or less to the North property line as indicated by short plat

Also including the necessary right of way to provide a turn around at the terminus point of this right of way as described, said turn around right of way not to exceed 100 feet in diameter, centrally located.
