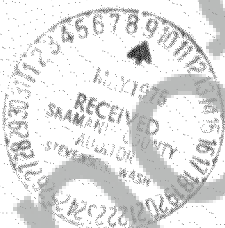


QUIT CLAIM DEED

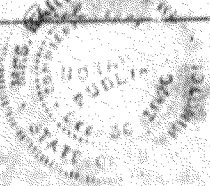
