For Unimproved Property

THIS CONTRACT, made this 7th day of HEL E. STEWART and VERNA M. STEWART, husband and wife, TOOD P. SLACK and MARY K. SLACK.

Mayr, 1975, hetween hereinafter called the "soiler" and hereinafter called the "purchaser,"

husband and wife, WITNESSETH: The seller agrees to sell to the purchaser, and the purchaser agreed to purchase of the

seller the following described real estate with the appurtenances, situate in Washington;

Skamania County.

Lot 10 of MAPLE MILL TRACTS NO. 3 according to the official plat thereof on file and of record at page 144 of Book A of Plats, Records of Skamania County, Washington.

Free of incumbrances, except. Restrictive covenants as set forth in agreement dated May 1, 1969, and recorded May 7, 1969, at page 389 of Book 60 of Geeds, under Auditor's File No. 70998, Records of Skamania County, Washington, relating to building limitations, restrictions on the use of the premises, and the keeping of animals.

On the following terms and conditions: The purchase price is ONE THOUSAND TWO HUNDRED and MO/100 - (\$ 1,200.00) dollars, of which (\$ 50.00 FIFTY and NO/100 has been paid, the receipt whereof is hereby acknowledged, and the purchaser agrees to pay the balance of said purchase price as follows:

The purchasers agree to pay the balance of the purchase price in the sum of One Thousand One Hundred Fifty and No/100 (\$1,150.00) Dollars in monthly installments of Fifty and No/100 (\$50.00) Dollars, or more, commencing on the second day of June, 1975, and on the second day of each and every month thereafter until the full amount of the purchase price together with interest shall have been maid. The said monthly installments shall include interest at the rate of six percent (6%) per annum computed upon the monthly balances of the unpaid purchase price, and shall be applied first to interest and then to principal. The purchasers reserve the right at any time they are not in default under the terms and conditions of this contract to pay without penalty any part or all of the unpaid purchase price, plus intorest, then due.

> It is agreed that the aforesaid Lot 10 will not be entitled to water services from the Maple Hill Water Company.

The purchaser may enter into possession on May 7, 1975

The property has been carefully inspected by the purchaser, and no agreements or representations pertaining thereto, or to this transaction, have been made, save such as are stated herein.

The purchaser agrees; to pay before delinquency all taxes and assessments assumed by him, if any, and any which may, as between grantor and grantee, hereafter become a lien on the premises; not to permit waste; and not to use the premises for any illegal purpose. If the purchaser shall fail to pay before dellinquency any such taxes or assessments, the seller may pay them, and the amounts so paid shall be deemed part of the purchase price and be payable forthwith with interest at the rate of ten per cent per annum until paid, without prejudice to any other right of the seller by reason of such failure.

The purchaser assumes all risk of the taking of any part of the property for a public use, and agrees that any such taking shall not constitute a failure of consideration, but all moneys received by the sall by reason thereof shall be applied as a payment on account of the purchase price, less any sums which the seller may be required to expend in procuring such moneys.

If seller's title to said real estate is subject to an existing contract or contracts under which seller is purchasing anid real estate, or any faortgage in other obligation, which seller is to pay, seller agrees to make such akyments in accordance with the terms thereof, and upon default, the purchaser shall have the right to make any payments next falling due the seller under this contract.

The sellen agrees, upon full compliance by this purchaser with his agreements herein, to elecute and

deliver to the purchaser a warranty

deed to the property, excepting any part which may have been condemned, free of incumbrances except those ab we mentioned, and any that may accrue hereafter through any person is her than the seller,

The seller agrees to furnish a Transamerica Title Insurance Campuny standard form purchaser's title policy when the purchaser shall have paid the furchase price in full insuring the title to said property with liability the same as the above purchase price, free from incumbrances except any which are assumed by the purchaser or as to which the conveyance hereunder is not to be subject.

Time is of the essence hereof, and in the event the purchaser shall fail to comply with or perform any Time is of the essence hereof, and in the event the purchaser shall fail to comply with or perform any condition or agreement hereof promptly at the time and in the manner herein required, the seller may elect to payments made hereunder, and all improvements placed point the termination of the purchaser's rights, all liquidated damages, and the seller shall have the right to re-enter and take possession of the property; and if the seller such forfeiture shall commence an action to procure an adjudication of the termination of the purchaser's rights hereunder, the purchaser agrees to pay the expense of searching the side for the purpose of such action, together with all costs and a reasonable attorney's fee.

Service upon purchaser of all demands, notices or other papers with respect to forfeiture and termination of purchaser's rights may be made by United States Mail, postage pre-paid, return receipt requested, directed to the purchaser at his address last known to the seller.
