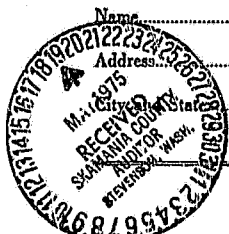

DEDICATION DEED

WILL E. MERRAN

GRANTOR(S) Sheridan Crothers and Betsey A. Crothers, husband & wife

for and in consideration of the sum of Ten Dollars and other valuable considerations

(\$ 10.00) Dollars, to us in hand paid, and in further consideration of the general public

welfare, do by these presents grant, convey and dedicate to SKAMANIA County,

State of Washington, for the use of the public as a county road and appurtenances the following de-

scribed real property in the County of SKAMANIA State of Washington:

A right of way for the reconstruction of the County Road known and designated as Salmon Falls Road (County Road No. 12130) located in the N.E. 1/4 of the S.W. 1/4 of Section 3, Township 1 North, Range 5 E.W.M. in Skamania County, Washington.

RIGHT OF WAY

More Particulary: A strip of land 35 feet in width lying easterly of and contiguous to the following described centerline from Station 29 + 70.14 to approximate Station 33 + 10.

CENTERLINE DESCRIPTION

Beginning at Engineer's Station 29 + 70.14, which point lies South 1,234.72 feet and West 909.62 feet from the center of Section 3, Township 1 North, Range 5 E.W.M. Thence N 27° 53' W 307.40 feet to P.C. Station 32 + 77.54; thence following a 9° 00' curve to the right 337.22 feet to P.T. Station 36 + 14.76; thence N 2° 28' E 603.19 feet to Station 42 + 17.95, said point lying S 88° 11' 40" W 1,101.28 feet from the center of Section 3, Township 1 North, Range 5 E.W.M.

Consisting of a total acreage of 0.21 acres less existing rights of way for a net acreage of 0.12 acres more or less.

TO HAVE AND TO HOLD the said described premises unto the said SKAMANIA

County and its successor or successors for the use of the public forever.
