

Deed and Seller's Assignment of Real Estate Contract

State of Washington including any interest therein which grantor may hereafter acquire:

The Southwest Quarter of the Northeast Quarter of the Southeast Quarter (SW $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 9, Township 3, North, Range 10 E. W. M.; EXCEPT that portion thereof lying within the 300 foot strip of land acquired by the United States of America for the Bonneville Power Administration's Bonneville-Coulee Nos. 1 and 2 transmission lines; TOGETHER WITH an easement for access over the existing road connecting with County Road No. 309. SUBJECT TO easements of record.

This deed corrects and supersedes deed dated August 21, 1974 and recorded in book 67 of Deeds at Page 514, records of Skamania County, Washington under Auditor's file No. 78110.

and does hereby assign, transfer and set over to the grantee that certain real estate contract dated the 13th day of March, 1972 between Harvey D. Kelchner, a single man

as seller and Jimmie Lee Roy Howard, a single man

as purchaser for the sale and purchase of the above described real estate. The grantee hereby assumes and agrees to fulfill the conditions of said real estate contract and the grantor hereby covenants that there is now unpaid on the principal of said contract the sum of \$4,195.20 on January 1, 1974, the date of death of Harvey Kelchner.
