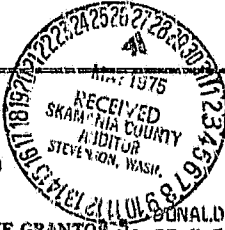

State of Washington including any interest therein which grantor may hereafter acquire:

A right of way forty (40) feet wide and across below described property for road. Said road to follow present Highway # 8 to top of hill to a gate constructed as of Dec. 11, 1964, thence in a northerly direction through the property described below.

THAT PORTION of the Northeast quarter of the Northeast quarter (NE1/4 NE1/4) and of Government Lot 5 of Section 5, lying Northern of Primary Highway # 8 in Township 1 North, Range 6 E.W.M. described as follows: Beginning at a point on the Northerly line of said highway 509.2 feet south and 254.3 feet east of the southwest corner of the Northeast quarter of the Northeast quarter (NE1/4 NE1/4) of said Section 6, thence North 512.2 feet to the rim of a certain cliff, thence following the rim of said cliff North 38° 32' west a distance of 449.3 feet to intersection with the west line of the Northeast quarter of the Northeast quarter of said section 6, thence North along the West line of the Northeast quarter of the Northeast quarter of said section 6- 961.3 feet to intersection with the North line of said section 6; thence east along the North lines of the said section 6 and section 5- 2638.3 feet to the Northeast corner of Government Lot 5 of said section 5; thence south along the east line of Government Lot 5 of said section 5- 1712.3 feet to the Northerly right of way line of said State Highway No. 8; thence along the northerly right of way line of said highway in a westerly direction 2378.2 feet more or less to the point of beginning.
