In this agreement so made one with the other, the date of acquiring property and all statements heretofore or hereafter made by either of us respecting alleged separate property, or affecting any property, are to be deemed, esteemed and regarded as of no force or effect whatsoever.

The full intent and purpose of this instrument is to be construed by the courts, our heirs, executors and assigns, and all other persons whomsoever, as a voluntary conveyance from one to the other, and unitedly to the community, of all our earthly possessions, in such form and manner that the same shall, from this date, be and constitute the property of our-selves, as husband and wife.

It further being our intention that in the event of the death of either of us, the said property hereinbefore mentioned in this instrument and declared to be the property

of the community of ourselves, as husband and wife, shall forthwith and without delay and expense, pass to the survivor; and we hereby mutually agree, one with the other, that in the event of the death of HERBERT SCHWARTZ while the said JOYCE E. SCHWARTZ survives, that the title to the whole of said community property shall at once vest in the said JOYCE E. SCHWARTZ, the real property in fee simple, and the personal property absolutely; and that in the event of the death of the said JOYCE E. SCHWARTZ leaving the said HERBERT SCHWARTZ surviving her, the title to the whole of said community property shall at once vest in the said HERBERT SCHWARTZ, the real property in fee simple and the personal property absolutely.
